## Results

- Part of defense team that prevailed in obtaining decision from Illinois Supreme Court and Second District Appellate Court affirming constitutionality and scope of immunity provided by Governor Pritzker's Executive Order 2020-19 for healthcare institutions and practitioners during the COVID-19 pandemic.
- Obtained partial summary judgment of negligence claims on behalf of local hospital for claim patient developed wound, applying Executive Order 2020-19 and the Illinois Emergency Management Agency Act.
- Obtained dismissal of negligence counts for wrongful death actions against long-term care facility in multiple matters for residents contracting COVID-19; utilized Governor Pritzker's Executive Order 2020-19.
- Obtained dismissal of willful and wanton counts for wrongful death actions against long-term care facility in multiple matters involving claims of wrongful death due to residents contracting COVID-19.
